Dear Sir(s),

Ministry of Power, Government of India vide its Order No. 46/8/2011-RE dated May 17, 2012 had appointed Shri Ajeet Kumar Agarwal as Director (Finance) of Rural Electrification Corporation Limited (REC) for a period of five years with effect from the date of taking over the charge of the post on or after August 1, 2012 or till the date of superannuation or until further orders, whichever event occurs the earliest.
